



## PERMANENT TEE-TIME CONTRACT FOR THE 2021 SEASON

This agreement, between River Bend Golf Club, referred to in this agreement as "CLUB", and "**Tee-time players**", referred to in this agreement as "PERMANENT TEE-TIME", grants the privilege of using the River Bend Golf Club and facilities according to the following terms and conditions.

**Dates excluded from play:** **River Bend Golf Club** reserves the right to eliminate play on dates of outing that will require clouser of the entire course due to shot-gun starts. Alternate tee-times will be given preference.

### Fees and Payments

A one time fee of **\$100.00** will be charged for **each four-some** prior to establishing the tee-time (based on availability). This is a non-refundable fee once paid, contract signed and times scheduled in the system.

### Cost/Payment Terms:

It is agreed upon by the CLUB and the PERMANENT TEE-TIME to pay \$22.00 per player per week to walk and \$32.00 per player per week to ride. Four players per week are expected per tee-time. If there are over four unpaid tee times total during the season, the tee-time will be lost.

- Term:** It is mutually understood and agreed that the CLUB shall reserve the tee for the SEASON (based on CLUB availability). Inclement days are determined by the playability of the course, as determined by the GROUNDS KEEPING STAFF.
- License for use of Golf Course and Facilities**  
The PERMANENT TEE-TIME shall have a revocable license to use the golf course and facilities of CLUB, during the term of this contract. The CLUB reserves the right to revoke the license of any PERMANENT TEE-TIME whose players, individually or collectively, violate provisions of this Contract, or the golf course rules and regulations adopted by the CLUB and/or otherwise posted at the CLUB facilities. PERMANENT TEE-TIME players shall be governed by the terms of this contract and the rules, regulations and policies of The River Bend Golf Club and violation of this license shall result in forfeiture of all playing privileges and PERMANENT TEE-TIME deposit

3. **Inclement Weather**

If the PERMANENT TEE-TIME cannot begin play within 15 minutes of scheduled time because of rain, snow, lightning or other adverse conditions, play must be cancelled, no penalty shall be issued to the PERMANENT TEE-TIME. If the PERMANENT TEE-TIME calls 48 hours in advance to cancel and remove their scheduled tee-time due to unforeseen circumstances, no penalty will be given.

4. **Pace of Play**

The PERMANENT TEE-TIME and all of its players commit themselves to play at a reasonable pace. Consideration will be given based on the pace of the group ahead of you but reasonable will be defined as follows: Two hours fifteen minutes to two and one half hours for nine holes. The first foursome on a given nine taking longer than two and one half hours will be deemed in violation of the slow play policy. A team who violates this slow play policy will receive one warning. A second violation by the same team will cause that team to lose their playing privileges for the next week and forfeit their fees for the remainder of the season. The PERMANENT TEE-TIME officer shall be notified of the first and second violations and maintain a record of violations.

5. **Alcoholic Beverages/Beverages**

All beverages may only be purchased in the clubhouse or on the grounds. If a player is drinking beverages on the golf course or grounds of the CLUB, not purchased here, including the parking lot, he/she and his/her team shall be removed from the premises immediately. The golf privileges of the offending player and team shall be terminated with a loss of all fees paid.

Coolers or any type of beverage containers containing alcoholic beverages or non-alcoholic beverages not purchased from the CLUB are strictly prohibited and subjects the offender to the same violation policy stated above, regardless of whether the player or team was actually consuming the alcoholic beverage(s).

Regulations pertaining to alcoholic beverages will be strictly enforced as required by the Illinois Liquor Control Commission.

6. **Golf Course Rules and Regulations**

Golf Course Rules and Regulations adopted by the CLUB at any time shall be binding on the PERMANENT TEE-TIME and its players. The Golf Course rules and regulations shall be provided to the PERMANENT TEE-TIME or shall be posted on the premises, but in either event, shall be deemed sufficient notice to the PERMANENT TEE-TIME. In the absence of local rules, the rules of the United States Golf Association shall govern play and customary golf course etiquette shall be required to assure that the sport of golf will remain a pleasant and enjoyable experience for the PERMANENT TEE-TIME and the CLUB.

- A. Local Rule: All out of bounds will be played as a lateral water hazard.
- B. All carts must remain at least 30 yards from greens and on cart path around tees.
- C. All players will fix their own ball marks and replace their own divots.

7. **Renewal**

It is further agreed that this contract does not imply that a contract will be available or offered for any other season other than that described herein, and that requests for renewal shall be made by the PERMANENT TEE-TIME no sooner than Sept 1, 2021 or later than Jan 15, 2022. The PERMANENT TEE-TIME will not be recognized or have playing privileges unless a new, fully executed contract is on file with the CLUB.

8. **Amendments**

It is agreed that any amendments, revisions or alterations to this Contract shall be in writing. Oral statements shall not have any binding effect. All notices, alterations or other writings concerning this Contract shall be in writing and must be provided by either facsimile transmission, delivering or causing to be hand-delivered a written copy thereof, or by sending a written copy through the United States mail and addressed as follows:
